## COPYRIGHT TRANSFER AGREEMENT (SZERZŐI JOGI NYILATKOZAT)

In order to ensure both the widest dissemination and protection of material published in **építőanyag** – *Journal of Silicate Based and Composite Materials*, authors are asked to transfer the rights of copyright in their paper. This enables the publisher to ensure protection against infringement. The transfer of copyright must be clearly stated in writing.

1. The author transfers herewith the copyright of the accepted paper titled above to the Scientific Society of the Silicate Industry (SZTE), publisher of **építőanyag** – *Journal of Silicate Based and Composite Materials*. The Copyright Transfer Agreement covers the exclusive rights comprised in the copyright, including but not limited to the right to publish the material given in the accepted paper, in all languages and in all media of expression now known or later developed, and to license or permit others to do so. For the avoidance of doubt, this assignment includes the rights to supply the article in electronic and online forms and systems.
2. The author warrants that the accepted paper is his/her original work and that he/she has full power to make this grant. The author signs for and accepts responsibility for releasing this material on behalf of any and all co-authors. The author states that the material given in the accepted paper is submitted exclusively to **építőanyag** – *Journal of Silicate Based and Composite Materials*, and has not been published before. If excerpts from copyrighted material are included, the author will obtain written permission from the copyright owners and take responsibility for the sources. The author declares that the accepted paper contains no libelous, abusive, defamatory, obscene, fraudulent or unlawful statements, no material or instruction that might cause harm or injury, does not infringe on the rights of others, and is not in any other way unlawful or in violation of applicable laws. The author warrants that wherever possible and appropriate, any patient, client or participant in any research or clinical experiment or study who is mentioned in the paper has given consent to the inclusion of material pertaining to him/her, and that he/she acknowledges that he/she cannot be identified in any way. The author warrants that appropriate warnings are included in the text of the paper concerning any particular hazard that may be involved in carrying out experiments or procedures described in the paper or involved in instructions, materials, or formulae, and explicitly relevant safety precautions are mentioned and given (if an accepted code of practice is relevant, a reference to the relevant standard or code is given).
3. Notwithstanding the above, the author retains the following rights:
  - 3.1. Proprietary rights other than copyright, such as patent rights.
  - 3.2. The right to make copies of all or part of the accepted paper for the author's use for educational purposes.
  - 3.3. The right to make copies and archive of the final print of the accepted paper in institutional or open access repositories (where Creative Commons License Attribution-NonCommercial, CC BY-NC applies) either with:
    - placing a link to the PDF file at **építőanyag** – *Journal of Silicate Based and Composite Materials* website,
    - placing the PDF file of the final print.
  - 3.4. The right to make oral presentations of material given in the accepted paper.
4. The author agrees that all copies made under any of the above conditions will include a notice of copyright and a citation to the accepted paper published in **építőanyag** – *Journal of Silicate Based and Composite Materials*. The author undertakes that the publisher is kept against all loss, damages, injury, costs and expenses (including legal and other professional fees and expenses) awarded against or incurred or paid by the publisher as a result of author's breach of warranties given in this agreement.
5. The publisher is responsible for preparing and publishing the accepted paper in **építőanyag** – *Journal of Silicate Based and Composite Materials*, however, the right is reserved to make such editorial changes as may be necessary to make the paper suitable for publication, or as it is reasonably considered necessary to avoid infringing third party rights or law; and the right is reserved not to proceed with publication for whatever reason. After submission of this Copyright Transfer Agreement signed by the corresponding author, changes in the authorship or in the order of the authors listed are not accepted.
6. This agreement (and any dispute, proceeding, claim or controversy in relation to it) is subject to Hungarian law. The graver cases of copyright infringement – in order to strengthen the protection of copyright – are considered as acts of crime and are punishable under the Hungarian Criminal Code as legal facts "infringement of copyright and neighboring rights", "circumvention of technological measures for the protection of copyright and neighboring rights" and "falsifying data related to copyright management".
7. This agreement may only be amended by a document signed by both the publisher and the author.
